

Board Minutes Monday January 18, 2016

The Board of Supervisors met with representatives of A&J Associates to receive the report on the investigation of the electrical, HVAC, and other mechanical systems at the Smith building at 11:00am January 14th. No actions were taken at this meeting.

The Board of Supervisors met at 9:30am on January 18, 2016 with all members present.

Lee Bjerke, county Engineer, met with the Board to discuss road matters.

The Board reviewed the bids for a new maintainer.

Moved by Beard and seconded by Kuhn to enter into the Memorandum of Agreement for archeology for bridge 407, on Pine Creek Road. Motion carried unanimously.

The Board reviewed the bids for project BLUF-116-6 for bridge 351. Moved by Kuhn and seconded by Ashbacher to accept the low bid by Brennan Construction for \$60,435. Motion carried unanimously.

Jessica Rupp, Riverview Center, met with the Board to discuss her agency's services for sexual assault victims and to request funding for FY17.

Moved by Kuhn and seconded by Ashbacher to appoint Sean Snyder as alternate to Northeast Iowa Response Group. Motion carried unanimously.

Charlene Selbee, Winneshiek County Convention and Visitors Bureau, met with the Board to give a project update and request funding for FY17.

Chopper Albert and Sandra Underbakke, IT department, met with the Board to give an update on the WEB site update project.

Faith Hlubek, county VA Administrator, met with the Board to give an update on a VA claim that took four years for approval.
